Yard Waste Pick-Up

Just a reminder, the Town of Greensboro has yard waste pick-ups on the 3rd Monday of every month. If you are trimming trees or bushes, please be sure that the brush is cut down to sections 4 foot or less to make it manageable for our Public Works Department. You can pile the brush neatly by the curb and we will pick it up from there. As for leaves, they must be in biodegradable bags which can be purchased at most hardware and home goods stores. We can not accept leaves in black yard or plastic bags. The company that we have pick up the yard waste from us will not take them in plastic bags.

Water and Sewer Bills/ Shut Off Days

Just a reminder, this quarter's water bills will be due July! You can make payments up until that date without signing a payment agreement; however, if your balance is not paid in full by 7/30 you will need to come into Town Hall and sign an agreement. Shut off day if payments or payment arrangements are not made will be August 14.

If you will be making payment arrangements the following will be the due dates and shut off days. All payment arrangements will need to be made by signing an agreement which can be obtained in Town Hall.

No License Required

There is now a space to fish along the river that doesn't require a license. The location is on the northwest side of the Sunset Avenue bridge. The area is clearly marked with signage. As long as you are fishing the bank between the signs you will not be required to obtain a license.



Grass can not exceed 10 inches in length. Also, you can not leave household items or indoor furniture out in your yard or on porches. Some other code violations that we have been seeing are broken windows, porches in need of repair, gutters and siding falling down, and untagged vehicles. If we notice any of these on your property, we will send you a reminder/warning letter. This letter will give you time to fix the violation before you begin receiving citations. If you have any questions or if you see any violations you think we may have missed please feel free to contact Town Hall.
