Ordinance 2017-O-10 was introduced:

AN ORDINANCE OF THE TOWN OF GREENSBORO ESTABLISHING A VACANT LOT FEE OF \$36.42 PER QUARTER TO COVER THE TOWN'S WASTEWATER TREATMENT SYSTEM DEBT SERVICE, TO BE ASSESSED AND COLLECTED AGAINST ANY VACANT LOT WITHIN THE CORPORATE LIMITS OF THE TOWN OF GREENSBORO WITH AN EXISTING CONNECTION TO THE TOWN'S WASTEWATER SYSTEM

Comm. Swafford sponsors Ordinance 2017-O-10.

Amber will call CUSI and ask about enlarging the reading field on the bills so if the reading number is larger than 5 characters it doesn't show up as asterisks.
