***Wheeler Drive:***

Jeannette brought to the council a complaint from a resident on Wheeler Drive.

Wheeler drive's pot hole has gotten really bad and she wants to know if the Town would fix the potholes or the entire road because it has become a major issue.

Last year when this issue was brought to the council they decided to do a onetime fix and fill in the pot holes. The resident has already called the county and they have said they will not fix it because it is not a county road.

Mayor Noon stated he would like to look into prices for different options to repair the road.
