Section 508. Filing for office.

Persons may be nominated for elected office in the town by filing a certificate of nomination at the Clerk's Office of said town before midnight on or before the first (1st) Tuesday in October preceding the town election. No person shall file for nomination to more than one (1) elective town public office or hold more than one (1) elected public office at any one time. (Res. No. 1986-R-2, November 21, 1986; Res. No. 2009-R-12, 11-6-09.)

IMPORTANT DATES

- Grass must be under 10inches
- Inoperative or unlicensed vehicles must be covered.
- Up to 4 domestic fowl per single-family dwelling. No roosters.
- All unenclosed swimming pools containing 2 feet of water or more shall be protected by a safety fence or barrier of 4 feet in height minimum and approved by the Zoning Administrator.

CODE ENFORCEMENT REMINDERS

- Water Bills are due April 17, 2025.
- May 2, 2025, end of grace period. Must have payment plan in place or have paid in full
  - June 6, 2025, due date for payment plan
  - June 9, 2025, disconnection date
